George Alter holds a Ph D in History of the University of Pennsylvania and a MA in Applied Economics of the University of Michigan. He is Professor of History and director of the Population Institute for Research and Training (PIRT) at Indiana University. He is the author of *Family and the Female Life Course: The Women of Verviers, Belgium, 1849-1880* (1988) and numerous articles in historical demography and economic history. His recent work compares demographic and family patterns in Europe and East Asia and examines the effects of conditions in childhood on health in old age.

Martin Conway is Fellow and Tutor in Modern history, Balliol College, University of Oxford. He has written about the extreme-right in Belgium during the inter-war years and World War II, and more generally on the extreme-right and political Catholicism in twentieth-century Europe. His publications include the monograph *Collaboration in Belgium: Léon Degrelle and the Rexist Movement 1940-1944* (1993) and the edited volumes (with T.C. Buchanan) *Political Catholicism in Europe, 1918-1965* (1996); *Catholic politics in Europe 1918-1945* (1997); (with J. Gotovitch) *Europe in Exile: European Exile Communities in Britain 1940-1945* (2001); and (with T. Buchanan) Special issue of *European History Quarterly* on *Democracy in Twentieth Century Europe* (2002). He is currently writing a book on Belgium after World War II as well as a broader history of post-war Europe.

Myron P. Gutmann, Ph D in History of Princeton University, is Professor of History and Director of the Inter-university Consortium for Political and Social Research at the University of Michigan. He is the author of *War and Rural Life in the Early Modern Low Countries* (1980), *Toward the Modern Economy, Early Industry in Europe, 1500-1800* (1988), and more than 50 articles and chapters. He has broad interests in interdisciplinary historical research, especially health, population, economy, and the environment.

Gerd-Rainer Horn, Ph D in History of the University of Michigan, is Senior Lecturer in Twentieth Century History at the University of Warwick (UK). He has taught at the universities of Huddersfield, Western Oregon University, Kassel and Montana State University. His research interests are with Transnational Continental Western European History, 1930s-1970s and the history of social movements. His publications include *European Socialists Respond to Fascism: Ideology, Activism and Contingency in the 1930s* (1996) and *The*

Spirit of '1968': Western Europe and North America (forthcoming 2006) as well as the edited volumes (with Emmanuel Gerard) *Left Catholicism: Catholics and Society in Western Europe at the Point of Liberation, 1943-1955* (2001) and (with Padraic Kenney) *Transnational Moments of Change: Europe 1945, 1968, 1989* (2004).

Horst Lademacher is emeritus Professor for Modern and Contemporary History and Low Countries Studies (*Niederlande-Kunde*) of the University of Münster. He has worked as a scientific collaborator at the International Institute for Social History in Amsterdam (IISG) and at the European Communities in Brussels. He received his *Habilitation* of the University of Bonn. After holding chairs at the Vrije Universiteit Amsterdam and at the University of Kassel (Hessen) he in 1990 was appointed Professor at the University of Münster and Director of the Zentrum für Niederlande Studien. He retired in 1999. He has published widely on the history of the Cold War, the international labour movement, and particularly about Dutch and Belgian history.

Janet Polasky, Ph D in History of Stanford University, is Professor and Chair of the Department of History at the University of New Hampshire. She is interested in comparative European history; Early modern and modern French history; European Women's history; and the history of European Socialism. Her major publications include *The Democratic Socialism of Emile Vandervelde, Between Reform and Revolution* (1994) and *Revolution in Brussels, 1787-1793* (1986). Her current research focuses on 'Social Planning in Britain, France and Belgium, 1869-1914' and the 'Comparative History of Women in Revolution, 1787-1793'.

Patrick Pasture is an Associate Professor of History at the KU Leuven, where he co-ordinates the research unit 'Modernity & Society 1800-2000'. His main fields of research are international and comparative labour history and social history of Christendom. He recently published, with Lex Heerma van Voss and Jan De Maeyer (eds.), *Between Church and Class. Comparative Histories of Christian Labour in Europe 1840-2000* (2005) and, with Michel Pigenet and Jean-Louis Robert (eds.), *L'Apogée des syndicalismes en Europe* (2005). He is currently working on a transatlantic history of Christendom in Western Europe and North America.

Tammy Proctor is Associate Professor and Chair of the Department of History at Wittenberg University, Springfield, OH. She obtained her Ph D at Rutgers University, New Brunswick, NJ. She specialises in the history of

Modern Europe and Britain, Women, Imperialism. Her publications include articles about guides and scouting as well as gender and intelligence, among which a monograph on *Female Intelligence: Women and Espionage in the First World War* (2003). It is the latter subject that raised her interest in Belgium. She is currently engaged in writing a civilian history of the First World War.

Carl S. Strikwerda is Dean of the Faculty of Arts at the College of William and Mary. He earned his bachelor's degree from Calvin College, and holds an M.A. in history from the University of Chicago and a Ph D from the University of Michigan. He taught at the State University of New York (Purchase), the University of California (Riverside) and the University of Kansas. He is a specialist in modern European history and the history of globalization, but has also published extensively on Belgian history. His publications include the monograph *A House Divided: Catholics, Socialists, and Flemish Nationalists in Nineteenth Century Belgium* (1997) and the edited volumes (with Ellen Furlough) *Consumers Against Capitalism? Consumer Cooperation in Europe, North America, and Japan, 1840-1990* (1999); and (with Camille Guerin-Gonzales) *The Politics of Immigrant Workers: Labor Activism and Migration in the World Economy, 1830 to the Present* (1998). He is currently working on a book tentatively entitled *The World at the Crossroads: The Great War and the Re-Making of Modern History*.
